The Greater Ann Arbor Quilt Guild ("Guild") is a non-profit organization managed by volunteers dedicated to the art and preservation of quilting, patchwork, appliqué, and related fiber arts.

What is a privacy policy?

We created this policy to help you understand what information we collect and how we intend to use it. We also let you know your rights.

Transmissions over the internet are never 100% secure or error-free. We have, however, implemented reasonable procedures to protect the confidentiality, security, and integrity of your data. We cannot completely guarantee that no part of our system or site will ever fail or be compromised. If you ever suspect that our site or services have contributed to your personal information being compromised, please contact us immediately so we can investigate and resolve the matter.

We reserve the right to change this Privacy Policy at any time to reflect new, unanticipated uses of personal information. We will notify Guild members when this is the case.

The following are guidelines we use for protecting the information you provide to us during a visit to our website.

How do we use your personal information?

The Guild does not knowingly add a user's personal information to our website without permission. A user's personal information can be used by our site when they sign up for our email communications, register themselves as a Guild member, or make a purchase related to a Guild-sponsored event.

The Guild uses two kinds of personal information for these transactions: personally identifiable information (PII) and non-personally identifiable information.

PII is information that can identify you personally. Examples you encounter every day are your full name, postal address, email address, driver's license, Social Security number or other government issued identification, account numbers, financial and medical records, biometrics,

username, password, and criminal history. This kind of data is especially sensitive and should be used on a "need to know" basis only. The Guild collects a subset of this information (full name, postal address, email address) only if you provide it.

PII that is less sensitive is the data available in public outlets and social media. Examples are gender, political association, race, and date of birth. The Guild does not collect this kind of data.

Non-personally identifiable information is aggregated or anonymized information that is generated by opening email messages, website page views, and other business analytics.

The following table summarizes the ways we collect and use your personally identifiable information.

How do we interact with third parties?

We do not display your contact information publicly on our website or share your PII to third parties, except for when 1) we have your permission to disclose, 2) the disclosure is necessary for the purpose for which the information was collected, 3) a third party is assisting us to provide or manage the services or website, or 4) where otherwise stated in this policy.

We also may disclose information where permitted by applicable law or when the disclosure is necessary, in our sole discretion, for the establishment or maintenance of legal claims or legal compliance, to satisfy any law, regulation, subpoena or government request, or in connection with litigation.

What about my purchase history?

The Guild uses your personally identifiable data that you provide when making an online purchase through our website or using a personal check. Your purchase transactional data is not stored on our website's servers and is not publicly available. We retain purchase records in accordance with generally accepted accounting practices.

What are your rules on social media and multimedia use?

The Guild reserves the right to film, record, or photograph any of the attendees at a sponsored event for promotional purposes after the event has taken place. Attendees are advised that this may result in incidental inclusion of your image or voice in any multimedia format.

Due to the prevalence of mobile recording devices in today's world, the Guild disclaims all liability for the capture of your image or voice in any multimedia format by other attendees at a sponsored event.

The Guild also uses social media (Facebook and Instagram) to post real-time photos and videos to our social media feeds, in compliance with these platform terms and conditions. Attendees are encouraged to post their own social multimedia content from an event provided it does not infringe on copyrighted material.

Event attendees are advised to use social media platforms wisely and engage with them with caution regarding their own privacy and personal details. See the privacy policies for these platforms: Meta.

The Guild website will never ask for personal or sensitive information through social media platforms. Anonymized and aggregated user data is reported for internal purposes only and never shared with third parties.

Email communications

The Guild sends email communications for blog posts, events announcements, and online meeting links. You may opt out of these communications by using the Unsubscribe link in the message. Members who opt out are removed from all future email communications, including online meeting links. You may request to be added back to the email list.

When you make a purchase through our website, you will receive an automated receipt confirmation message. These are required notices and are not optional.

Cookies

Cookies are small pieces of data that help the user and software interact in an online environment. Cookies help with functionality, statistics, or marketing/targeting. The Guild does not participate in ad exchanges. Usage statistics are anonymized and used for analysis only.

Cookies used for the Guild website vary in duration. Some expire at the end of the session, others expire after designated time periods. Persistent cookies are used to store information across sessions.
